### **UNDERVALUED STOCKS**

The PEG ratio is a company's Price/Earnings ratio divided by its earnings growth rate over a period of time (typically the next 1-3 years). The PEG ratio adjusts the traditional P/E ratio by taking into account the growth rate in earnings per share that are expected in the future. In general, a good PEG ratio has a value lower than 1.0.
